

**ORDINANCE AMENDING ORDINANCE #2008-1111-1 ORDINANCE ADDRESSING
FLOODPLAIN MANAGEMENT PROVISIONS OF THE STATE CONSTRUCTION CODE
GREENDALE TOWNSHIP, MIDLAND COUNTY, MICHIGAN
ORDINANCE #2013-0108-01**

This is an Ordinance to affirm an enforcing agent to discharge the responsibility of the Township of Greendale, Midland County, Michigan, and to designate regulated flood hazard areas under the provisions of the Michigan State Construction Code Act, Act #230 of the Public Acts of 1972, as amended.

The Township of Greendale ordains:

Section 1. AGENCY DESIGNATED. Pursuant to the provisions of the Michigan State Construction Code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Building Official of the Township of Greendale is hereby designated as the enforcing agent to discharge the responsibility of the Township of Greendale under Act 230, of the Public Acts of 1972, as amended. The Township of Greendale assumes responsibility for the administration and enforcement of said Act throughout the corporate limits of the community adopting this Ordinance.

SECTION 2. CODE APPENDIX ENFORCED. Pursuant to the provisions of the Michigan State Construction Code, in accordance with Section 8b(6) if Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agent within the Township of Greendale.

SECTION 3. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS. The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) entitled Midland County, Michigan (All Jurisdictions) dated January 16, 2013 and the Revised Flood Insurance Map(s) (FIRMS) map panels of 26111C; 0205E, 0210E and 0228E dated May 4, 2009 as finalized and 26111C; 0150F effective January 16, 2013 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

SECTION 4. REPEALS. All Ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 5. PUBLICATION. This Ordinance shall be effective after legal publication and in accordance with the provisions of the Act governing same.
